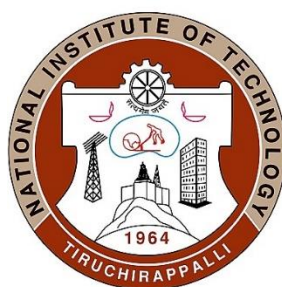

# **Part - 1 Bidding Procedures**

## Section I: Instructions for Online Bid Submission

Instructions to the Bidders to submit the bids online through the Central Public Procurement Portal for e Procurement at <https://eprocure.gov.in/eprocure/app>.

1. Possession of valid Digital Signature Certificate (DSC) and enrollment / registration of the contractors / bidders on the e-Procurement/e-tender portal are prerequisite for e-tendering.
2. Bidder should register for the enrollment in the e-Procurement site using the “Online Bidder Enrollment” option available on the home page. Portal enrollment is generally free of charge. During enrollment / registration, the bidders should provide only valid and true information including valid E-mail id. All the correspondence shall be made directly with the contractors/bidders through E-mail id as registered.
3. Bidder need to login to the site through their user ID / password chosen during enrollment / registration.
4. Then the Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by SIFY / TCS / nCode / eMudra or any other Certifying Authority recognized by Controller of Certifying Authorities (CCA) India on eToken / SmartCard, should be registered.
5. The registered DSC only should be used by the bidder in the transactions and should ensure safety of the same.
6. Contractor / Bidder may go through the tenders published on the site and download the tender documents/schedules for the tenders.
7. After downloading / getting the tender document/schedules, the Bidder should go through them carefully and then submit the documents as required, otherwise bid will be rejected.
8. Any clarifications may be sought online through the tender site, through the contact details or during pre-bid meeting if any. Bidder should take into account the corrigendum if any published before submitting the bid online.
9. Bidder may log in to the site through the secured login by the user id / password chosen during enrolment / registration and then by submitting the password of the e-Token / Smartcard to access DSC.
10. Bidder may select the tender in which he / she is interested in by using the search option and then move it to the ‘my tenders’ folder.
11. From my tender folder, he / she may select the tender to view all the details uploaded there.
12. It shall be deemed that the bidder has read and understood all the terms and conditions before submitting the offer. Bidder should go through the tender schedules carefully and upload the documents as asked ; otherwise, the incomplete bid shall stand rejected.
13. Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and ordinarily it shall be in PDF /xls / rar / jpg / dwf formats. If there is more than one document, all may be clubbed together and provided in the requested format. Bidders Bid documents may be scanned with 100 dpi with black and white option. It is advisable that each document to be uploaded through online for the tenders should be less than 2 MB. If any document is more than 2MB, it can be reduced through zip / rar and the same if permitted may be uploaded. The file size being less than 1 MB the transaction uploading time will be veryfast.
14. The Bidders can update well in advance, the documents such as certificates, annual report details etc., under “My Space option” and these can be selected as per tender requirements

and then send along with bid documents during bid submission. This will facilitate the bid submission process faster by reducing upload time of bids.

15. Bidder should submit the Tender Fee / EMD as specified in the tender. The hard copy should be posted / couriered / given in person to the Tender Inviting Authority, within bid submission due date and time as indicated in the tender. Scanned copy of the instrument should be uploaded as part of the offer.
16. The details of the DD / any other accepted instrument, physically delivered, should tally with the details available in the scanned copy and the data entered during bid submission time, otherwise submitted bid shall not be acceptable or liable for rejection.
17. The bidder has to select the payment option as offline to pay the Tender FEE / EMD as applicable and enter details of the instruments.
18. While submitting the bids online, the bidder shall read the terms and conditions and may accept the same to proceed further to submit the bid packets.
19. The bidder has to digitally sign and upload the required bid documents one by one as indicated. Very act of using DSC for downloading the bids and uploading their offers shall be deemed to be a confirmation that they have read, understood and agreed with all clauses of the bid document including General conditions of contract without any exception.
20. The bidder has to upload the relevant files required as indicated in the cover content. In case of any irrelevant files, the bid may be rejected.

#### **PRICE BID**

21. If the price bid format is provided in a spread sheet file like BoQ\_XXXXX.xls, the rates offered should be entered in the allotted space only and uploaded after filling the relevant columns. The Priced-bid / BOQ template shall not be modified / replaced by the bidder ; else the bid submitted is liable to be rejected for the tender.
22. The bidders are advised to submit the bids through online e-tendering system to the Tender Inviting Authority (TIA) well before the bid submission due date and time (as per Server System Clock). The TIA shall not be held responsible for any delay or the difficulties faced during the submission of bids online by the bidders.
23. The time settings fixed in the server side and displayed at the top of the tender site, shall remain valid for all actions of requesting, bid submission, bid opening etc., in the e-Tender system. The bidders should follow such time during bid submission.

#### **EVIDENCE FOR ONLINE BID SUBMISSION**

24. After the bid submission (i.e. after Clicking “Freeze Bid Submission” in the portal), the acknowledgement number indicated by the system should be printed by the bidder and kept as a record of evidence for online submission of bid for the particular tender and also be used as entry pass to participate in the bid opening.
25. All the data being entered by the bidders would be encrypted using Public Key Infrastructure (PKI) encryption techniques to ensure the secrecy of the data. The data entered is not retrievable by unauthorized persons during the bid submission and until the time of bid opening by anyone.
26. Any bid document that is uploaded to the server is subjected to symmetric encryption using a system generated symmetric key. Further this key is subjected to asymmetric encryption using buyers/bid openers’ public keys. Overall, the uploaded tender documents become readable only after the tender opening by the authorized bid openers.

27. The confidentiality of the bids is maintained with the use of Secured Socket Layer (SSL) 128 bit encryption technology. Data storage encryption of sensitive fields is done.
28. The bidder should logout of the tendering system using the normal logout option available at the top right hand corner and not by selecting the (X) exit option in the browser.

<b>1</b>	<b>SCOPE OF BID</b>	
		Design, Manufacture, Supply, Installation, Testing and Commissioning of 50 kW capacity downdraft biomass gasifier based power plant in Athanavur Village, Yelagiri Hills, Tamil Nadu. as per Specifications. Through out these Bidding Documents unless the context otherwise requires : “ a. ‘in writing ’ means communicated in written form (e.g. by mail, e-mail, fax, telex) with proof of receipt; b. ‘ Institution means National Institute of Technology, Tiruchirappalli’
<b>2</b>	<b>ELIGIBLE BIDDERS</b>	
	2.1	A Bidder may be a firm, a company, a Limited Liability Partnership (LLP), a government-owned entity or any combination of such entities in the form of a Joint Venture (JV) under an existing agreement.
	2.2	In the case of a joint venture, all members shall be jointly and severally liable for the execution of the contract in accordance with the Contract terms. The JV shall nominate a Representative who shall have the authority to conduct all business for and on behalf of any and all the members of the JV during the bidding process and during the contract execution in the event the JV is awarded the contract.
	2.3	A Bidder shall not have a conflict of interest. Any Bidder found to have a conflict of interest shall be disqualified. A Bidder may be considered to have a conflict of interest for the purpose of this bidding process, if the Bidder:
	a	directly or indirectly controls, is controlled by or is under common control with another Bidder; or
	b	receives or has received any direct or indirect subsidy from another Bidder; or
	c	has the same legal representative as another Bidder; or
	d	has a relationship with another Bidder, directly or through common third parties, that puts it in a position to influence the bid of another Bidder, or influence the decisions of the Purchaser regarding this bidding process; or
	e	Participates in more than one bid in this bidding process. Participation by a Bidder in more than one Bid shall result in the disqualification of all Bids in which such Bidder is involved. This, however does not limit the inclusion of the same subcontractor in more than one bid; or
	f	Has a close business or family relationship with a professional staff of the Purchaser (or of the project implementing agency, or of a recipient of a part of the loan) who: (i) are directly or indirectly involved in the preparation of the bidding documents or specifications of the contract, and/or the bid evaluation process of such contract; or (ii) would be involved in the implementation or supervision of such contract.
	2.4	A foreign firm and individual may be ineligible if as a matter of law or regulations, India prohibits commercial relations with the country of bidder.

	2.5	A Bidder shall provide such evidence of eligibility satisfactory to the Purchaser, as the Purchaser shall reasonably request.
<b>3</b>	<b>CONTENTS OF BIDDING DOCUMENT</b>	
	3.1	The Bidding Documents consist of Parts 1, 2, 3 and 4, which include all the Sections indicated below, and should be read in conjunction with any Addenda if any, issued.
	3.2	The Invitation for Bids issued by the Purchaser is not part of the Bidding Document.
	3.3	Unless obtained directly from the Purchaser, the Purchaser is not responsible for the completeness of the document, responses to requests for clarification, the Minutes of the pre- Bid meeting (if any), or Addenda to the Bidding Document. In case of any contradiction, documents obtained directly from the Purchaser shall prevail.
	3.4	The Bidder is expected to examine all instructions, forms, terms, and specifications in the Bidding Documents and to furnish with its Bid all information or documentation as required by the Bidding Documents.
<b>4</b>	<b>CLARIFICATION OF BIDDING DOCUMENTS, SITE VISIT, PRE-BID MEETING</b>	
	4.1	A Bidder requiring any clarification of the Bidding Document shall contact the Purchaser in writing at the Purchaser's address specified in the BDS or raise its enquiries during the pre-bid meeting if provided. The Purchaser will respond in writing to any request for clarification, provided that such request is received prior to the deadline for submission of bids within a period specified in the BDS.
	4.2	The Bidder is advised to visit and examine the project site and obtain for itself on its own responsibility all information that may be necessary for preparing the bid and entering into a contract for procurement of Goods. The costs of visiting shall be at the Bidder's own expense
	4.3	The Bidder's designated representative is invited to attend a pre-bid meeting. The purpose of the meeting will be to clarify issues and to answer questions on any matter that may be raised at that stage.
	4.4	The Bidder is advised to submit any questions in writing to reach the Purchaser not beyond one week preceding the meeting.
	4.5	Minutes of the pre-bid meeting, if applicable, including the text of the questions asked by Bidders, without identifying the source, and the responses given, together with any responses prepared after the meeting, will be transmitted promptly to all Bidders who have acquired the Bidding Documents. Any modification to the Bidding Documents that may become necessary as a result of the pre-bid meeting shall be made by the Purchaser exclusively through the issue of an addendum and not through the minutes of the pre-bid meeting. Absence in the pre-bid meeting shall not be a cause for disqualification of a Bidder.
<b>5</b>	<b>Amendment of Bidding Document</b>	
	5.1	At any time prior to the deadline for submission of bids, the Purchaser may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective bidder, modify the bidding documents by corrigendum. 	5.2	Any addendum issued shall be part of the Bidding Documents and shall be communicated in writing to all who have obtained the Bidding Documents from the Purchaser. The Purchaser shall also promptly publish the addendum on the Purchaser's webpage.

	5.3	The Purchaser may, at its discretion to give prospective Bidders reasonable time in which to take an addendum into account in preparing their bids, extend the deadline for the submission of bids.

But the gasifier system shall be supplied with a warranty/guarantee for three years from the date of commissioning. Any failure and improper functioning/operation shall have to be rectified by the supplier at free of cost. In case, the system fails to perform satisfactorily despite rectification by

the suppliers, the supplier shall have to replace the same by a new system and cost towards dismantling, packing, transporting and replacement by a new system, fresh erection and commissioning, trial run and handing over etc. will have to be borne by manufacturer/suppl

### **Section V. Institute against the Corrupt and Fraudulent Practices**

Institute strictly adheres to its policy against corruption and requires that bidders and their agents, subagents, sub-contractors, suppliers etc. shall not indulge in any kind of corrupt practices, fraudulent practices, collusive practices, coercive practices, obstructive practices or other kinds of corruption declared as crimes under Indian law.

- (v) "Obstructive Practice" is deliberately destroying, falsifying, altering, or concealing of evidence material to the investigation or making false statements to investigators in order to materially impede an investigation into allegations of a corrupt, fraudulent, coercive or collusive practice ; and / or threatening, harassing or intimidating any party to prevent it from disclosing its knowledge of matters relevant to the investigation or from pursuing the investigation.

b) Besides actions under clause (a) Institute may also take action to blacklist such bidder either indefinitely or for a specified period.

- Electricity requirements will be provided only at the installation time of the system. (Units required have to be mentioned by the tenderer immediately after the release of the sanctioned purchase order.)

## 5 Detailed Specification

5.1 Type: Downdraft Biomass Gasifier.

5.2 Capacity: Suitably rated biomass gasifier for operation with a modified gas engine for electrical output of 50 kW while operating on 100% producer gas engine.

5.3 Biomass fuel feeding system: The biomass fuel will be fed manually. The unit will be provided with a ladder and platforms fabricated MS sections suitable for the operational requirement.

5.4 Material for fabricating the Gasifier: Appropriate materials shall be used for the fabrication of the equipment. The main reactor shell shall be made of stainless steel – (SS310/Suitable equivalent) while other structural components like support structure, load taking cones, hopper top and feed door may be made out of appropriately thick MS plates. In the reaction zone, critical sections of nozzles and throats will be made from appropriate grade of

stainless steel (SS-310/Suitable equivalent). The complete fabrication should strictly follow the standard operation of the practice.

A staircase including a small platform shall be provided of MS structural for movement of workers engaged in loading of Biomass fuel.

5.5 Fuel flexibility: To be Specified by the Vendor.

5.6 Types of Fuel and recommended size: Agro residue waste and woody biomass of the following sizes are available at the site. The recommended size of Biomass:

Length : 10 cm – 20 cm

Diameter : 5 cm - 10 cm

5.7 Moisture Content: The Maximum allowable moisture content of the feedstock is to be specified by the Vendor.

5.8 Average Calorific Value of Generated gas Should be in the range of 1200 -1300 kcal/Nm<sup>3</sup>. – (Appropriate range has to be Specified by the Vendor in the bid).

5.9 Maximum Thermal Energy Output To be mentioned by the vendor but should not be less than 1,50,000 kCal/hr ~ (180 kW thermal)

5.10 Biomass consumption over the Turndown ratio <math>1.1 \pm 0.1 \text{ kg./kWh}</math> (Agro-waste & woody biomass)

5.11 Gasifier over the Turndown Ratio: To be specified by the vendor but should be more than 4

5.12 Minimum Capacity of Hopper for continuous operation: The hopper capacity should be suitably designed such that 3 to 4 hours of non-stop operation is ensured at peak load conditions.

5.13 Quantity of gas generated: The exact range is to be specified by the vendor in the technical bid.

5.14 Auxiliary power required: The exact range is to be specified by the vendor in the technical bid.



5.15 Cracking & Particulate Content of the Gas: The Gasifier should be capable of complete tar cracking. The hot gas leaving the gasifier should be generally tar free. Sequential scrubbing and filtration are performed to obtain the below-mentioned values.

(a) Maximum allowable Tar content :: 15 mg/Nm<sup>3</sup>

(b) Maximum allowable Particulate :: 15 mg/Nm<sup>3</sup>

5.16 Scrubbing and Filtration: Vendors are free to quote for both dry and wet scrubbing systems with necessary downstream equipment. So that the final gas quality is in line as mentioned in Section 5.15

(Note: If a wet scrubbing system is proposed provision for recycling the water out of the scrubbing unit should be provided by the vendor). The vendors should include the proper bill of quantity and spare list for the whole scrubbing and filtration systems.

d) Cooling system: The producer gas temperature at the engine inlet should be close to ambient temperature (+ 5 deg.C is allowed), whereas the gas temperature at any point of time should not exceed 35 deg.C at engine inlet).

5.19 Conditioning of Producer Gas In the continuation of Section 5.18 the gas cleaning and cooling must be accomplished to a high degree with the help of a suitably designed Cyclone, a gas cooler, scrubber and filter.

5.20 Gasifier Control Panel Control panel made up of CRCA Sheets with necessary instrumentation and control logic has to be provided with suitable indicators related to the operation of blower, pumps and vibrator motors, temperature and allied sensing devices.

5.21 System assembly and auxiliaries units •

Couplings, flanges, anti-vibration pads, foundation bolts, fasteners etc as required for the installation of the complete plant shall be provided along with the main equipment. This will also include necessary gaskets, washers and seals, other accessories and consumables required for erection.

- Sample collection points is to be provided at inlet and exit of each subsystem to monitor the quality of gases.
- Suitable ladder fabricated with MS angle sections and a small platform to facilitate loading of biomass fuel.

## **6 Auxiliary Equipment Specification**

### **6.1 Auxiliary Equipment Of Gasifier**

The vendors should submit the proper bill of quantity and spare list for the necessary auxiliary equipment (But not limited to the items mention in Section 6.2 -6.7) require for the ensured continuous operation of the system.

**6.2 Blowers** The vendors should supply the required number of appropriate rated blowers suitable for 50 kW (net electrical output) operating Gasifier system. The body and the impeller should be made of SS-316. The blower should be compatible with the Biomass gasifier and the components should be capable of operating for at least 10 years. The blower shall be suitable for regulating the flow of gas and for flaring the gas as and when necessary.

**6.3 Vibrator**

A Vibrator shall be provided to prevent clinker formation (if any). The rating of the vibrator motor shall be suitable and sufficient for the trouble free operation for which the BOQ and specification list has to be mentioned by the vendor in the bid.

**6.4 Water Cooling, cleaning and recycling systems.**

With reference to Section 5.18 the downstream water from the gasifier has to be properly treated that matches the Tamil Nadu Pollution Control Board (TNPCB) Norms. The vendors should ensure the water quality from the outlet of water treatment system (as suggested by the vendor) should lie within the range as specified by TNPCB Norms.

**6.5 Biomass Feed Handling System** Feeding will be carried out Manually. So there is no need for feed handling systems. However, the hopper design should be in line as mentioned in section 5.12.
